In accordance with N.J.S.A. 19:44A-20.4 et seq., the Ocean County Library is requesting qualifications (RFQ) from law firms or individuals licensed to practice law in the State of New Jersey that wish to provide general counsel and litigation services to the Library Commission for the calendar year 2019.

The successful firm(s) and /or individuals must have a primary office in Ocean County and have a minimum of five years' experience in representing a New Jersey Library and/or other public entities in contractual matters; civil service and personnel matters; public contracts; intergovernmental contracts; federal and state agreements; joint ventures; partnership and grant agreements; liability and workers compensation matters; OPRA; and general litigation.

The successful firm(s) and or individuals will provide the Library Commission with legal guidance relating to but not necessarily limited to:

Legal Counsel Services:

- 1. Legal research and/or advisory opinions if needed;
- 2. Represent the Library Commission in all matters in Federal and State courts as well as administrative tribunals and forums;
- 3. Review and/or draft Library Commission Resolutions, Contracts, Inter-Local and Inter-Agency agreements;
- 4. Must attend all monthly meetings of the Library Commission, all special meetings of the Library Commission, and all monthly meetings of the Library Foundation as requested, and provide the name of the person who will be attending;
- 5. Be readily available for meetings with any department heads or their designates upon request;
- 6. Advise the Library Commission of changes in State or Federal law or regulations, as well as court decisions, which may impact the Library Commission;
- 7. Any other matters as directed by the Commission.

ALL SUBMISSIONS SHALL INCLUDE THE FOLLOWING MINIMUM INFORMATION

- 1. Name of the individual(s) to be assigned to perform the tasks.
- 2. Professional experience and education of the individual(s) to be assigned, including a listing of experience with the Ocean County Library Commission and/or experience with other New Jersey Libraries and/or other public entities.
- 3. A statement concerning the ability of the firm/individual(s) to perform tasks assigned by the Commission in a timely fashion.
- 4. Professional licenses and certifications held by the individual(s) to be assigned.
- 5. A description of the support staff available to the individual(s) to be assigned.
- 6. A copy of a Certificate of Insurance, issued by an insurance carrier licensed by the State of New Jersey, for the firm/individual showing the amount of professional liability insurance and all other insurance coverages in place as of January 1, 2019. Primary Coverage: The insurance policies and coverage provided by the proposer to the Ocean County Library shall apply as primary coverage with respect to any other insurance or self-insurance program afforded to the Ocean County Library. There shall be no endorsement or modification of this coverage to make it excess over other available insurance coverage; alternatively if the CGL and umbrella, excess of reinsurance states that it is pro-rata, it shall be endorsed to be primary with respect to the Ocean County Library.
- 7. Worker's Compensation-Limits according to Worker's Compensation Laws of the State of New Jersey.
- 8. Contractors Liability not less than \$100,000.
- 9. Comprehensive General Liability Bodily Injury \$500,000 per person; \$1,000,000 per occurrence
- 10. Comprehensive General Liability shall include the following: Coverage for explosion, collapse or underground hazards, occurrence basis coverage, broad form property damage coverage and coverage for personal injury sustained by any person as a result of an offense directly or indirectly related to the employment of such person by the insured.
- 11. Automobile Liability- Business Auto liability insurance or its equivalent with a minimum of \$1,000,000. Per accident and including coverage for all of the following. Liability arising out of the ownership, maintenance or use of any auto; auto non-ownership and hired car coverage.
- 12. Contractor's Worker's Compensation, Comprehensive General Liability and Comprehensive Automobile Liability arising out of subcontractor's operations shall be identical as that listed above. Professional Liability or Errors and Omissions Liability Insurance appropriate to the Contractor's profession with a minimum limit of \$1,000.000.
- 13. Copies of each insurance certificate shall be furnished to the Library with the proposal. The proposer, if awarded a contract, agrees to protect, defend and save harmless the Library against any damage for payment for the use of any patented material process, article or device that may enter into the manufacture, construction or form a part of the work covered by either order or contract, and he further agrees to indemnify and save harmless the Library from suits or actions of every nature and description brought against it, for, or on account of injuries or damages received or sustained by any party or parties by, or from any of the acts of the proposer, his servants, or agents.

- 14. A list of (4) professional references with addresses and telephone contact numbers. Three (3) must have direct knowledge relating to your experience in the requested service.
- 15. A copy of your New Jersey Certificate of Employee Information Report Approval pursuant to N.J.A.C. 17:21-1.1 et. Seq. or a completed Form AA-302 Initial Employee Information Report.
- 16. A copy of your New Jersey Business Registration Certificate.
- 17. Hourly Rate Schedule for Legal Counsel Services. Cost may not be a factor in making award.

- 2. Must be enclosed in a sealed envelope bearing the name and address of the submitter, the name of this RFQ and the RFQ due date on the outside of the envelope.
- 3. Responses which are to be hand delivered the day of the opening must be taken and presented to the Library Purchasing Department at the time the responses to this RFQ are called for.

- 5. The Library will not be responsible for late mail deliveries and no responses to this RFQ will be accepted by the Library if received after the time stipulated in this notice.
- 6. An original and three copies of your response to this RFQ must be submitted for your response to be deemed complete.
- 7. The Library reserves the right to reject any or all proposals, or to waive any informality in the proposals and to accept any proposal deemed in the best interest of the Library.

SELECTION CRITERIA

A three-person committee consisting of management personnel and library commissioners will review and rank all responses. The selection criteria to be used in awarding a contract for the services described herein, shall include:

- 1. Qualifications of the individuals who will perform the tasks and the amounts of their respective participation. The Library Commission reserves the right to have a personal interview with the person who will be full time on the account;
- 2. Experience in providing the professional services requested by the Library Commission and references related thereto including the name of the person at the firm who will be handling the day- to- day matters of the account;

- 3. Ability to perform the tasks in a timely fashion, including staffing and experience with the subject matter including Library Laws of New Jersey and Confidentiality of Library Records; Intellectual Freedom; Censorship and First Amendment Issues; Filtering; Privacy and Confidentiality; the American Library Association's Library Bill of Rights and Freedom to Read Statement; the U.S.A. Patriot Act; and the Commission;
- 4. Experience in the construction of library facilities under N.J.A.C.
- 5. Location (distance) of primary office in relation to the Library Commission's administrative offices.
- 6. Thoroughness and completeness of the applicant's submittal.
- 7. Recent, current and projected workload of the individual and firm.
- 8. Hourly Rates.

AWARD

The Library shall award a contract to the firm or firms that best meet the needs and interests of the Library Commission.

The Commission reserves the right to negotiate the terms and conditions of a contract with the successful firm(s) and /or individual to obtain the most cost advantageous services for the Commission.

GENERAL CONDITIONS

Starting in January 2007, all business entities are advised of their responsibility to file an annual disclosure statement of political contributions with the New Jersey Election Law Enforcement Commission (ELEC) pursuant to N.J.S.A. 19:44A-20.27 if they receive contracts in excess of \$50,000 from public entities in a calendar year. Business entities are responsible for determining if filing is necessary. Additional information on this requirement is available from ELEC at 888-3 13-3532 or at www.elec.state.nj.us.

It is further agreed and understood that the LIBRARY assumes no obligation to indemnify or save harmless the CONTRACTOR, its agents, servants, employees and subcontractors for any claim which may arise out of their performance of this Agreement. Furthermore, the CONTRACTOR expressly understands and agrees that the provision of this indemnification clause shall in no way limit the CONTRACTOR'S obligations assumed in this Agreement, nor shall they be construed to relieve the CONTRACTOR from any liability, nor preclude the LIBRARY from taking any other actions available to it under any other provisions of this Agreement or otherwise at law.
